2. Eligibility Criteria

The bidder should:

1. Be a legally registered firm, agency, supplier proprietor engaged in the supply of food and mess related items.
2. Possess valid registration under the applicable laws and regulations.
3. Possess valid PAN, GST registration, whenever applicable, and other statutory registrations.
4. Possess a valid FSSAI License/registration for food items, wherever applicable.
5. Have adequate experience and capacity for regular supply of the required items.
6. Be capable of ensuring timely delivery of fresh and good-quality items at the EMRS premises.
(All the relevant documents should be submitted along with tender form)

3. Terms and Conditions

1. The successful bidder shall supply items strictly as per the specifications quality standards and requirements prescribed by the school.
2. All food items, vegetables and fruits supplied must be fresh, hygienic and fit for human consumption.
3. The Principal or an authorized committee shall have the right to inspect and reject any item found to be substandard, damaged, stale, adulterated or otherwise unsuitable.
4. The supplier shall replace rejected items immediately at his/her own cost.
5. The supply must be made regularly and within the stipulated time as communicated by the school.
6. The quantities mentioned in the requirements are indicative and may increase or decrease according to the actual requirements.
7. The successful bidder shall be responsible for transportation, loading, unloading and delivery of the items at the designated location without any additional charge.
8. Rates quoted by the bidder shall include all applicable taxes, transportation and other incidental expenses, unless otherwise specified.
9. The rate contract shall ordinarily remain for a period of 5 months, subject to satisfactory performance and availability of funds.
10. Payment shall be made on submission of bills after verification and acceptance of the supplies, subject to the availability of funds and completion of necessary formalities.
11. The school reserves the right to terminate the contract in case of unsatisfactory performance, supply of inferior quality items or violation of the terms and conditions.
12. The Principal reserves the right to accept or reject any or all tenders without assigning any reasons.
13. In case of any dispute, the decision of the competent authority shall be final and binding.

4. Tender Schedule

1. The tender paper can be purchased on payment of Rs. 500/- for each set of tender forms from the Office of EMRS Gamnom Sapormeina with effect from 12.09.2026 during office hours. However, during submission of tender forms, an amount of Rs. 500/- per set in the form of draft should be deposited in favor of Eklavya Model Residential School Sapormeina as cost of tender form.
2. The last date of submission of completed sealed tenders along with the EMD in the form of Demand Draft in favor of Eklavya Model Residential School Sapormeina in the Office of Principal cum Administrator is 24.09.2026 and 2:00 PM physically.
